# - Hirer Terms and Conditions 2021

Rosny Farm - which includes the Barn, Schoolhouse Gallery and Rosny Cottage – is home to Clarence Council's broad ranging and busy arts program encompassing exhibitions, concerts, workshops and events.

The Barn at Rosny Farm is a multi-purpose, small capacity arts venue situated in the cultural hub of Hobart's Eastern Shore.

Contained within the walls of a c1818 stone barn, it has been tastefully refurbished to retain its colonial aspect whilst catering to a broad range of arts based activities.

Situated within the picturesque grounds of the Rosny Farm, it has been described as, "The best acoustic venue in the Southern Hemisphere." – Stefan Grossman.

**Please note:** Due to the busy schedule of arts activities on-site it is not possible to caterfor weddings or private parties within any of the Rosny Farm buildings.

#### **Barn Facilities:**

Useable floor area 21.5m x 6m Capacity for up to 80 people seated with current COVID restrictions Wheelchair accessible Male, female and disabled access toilets (nearby on site)

### **Hirer Terms and Conditions**

- **Two weeks prior** to the event the hirer to confirm requirements: Staging, panels, lighting, access and required equipment.
- For access and technical information, a representative of your organisation will need to pick up a key and security info as well as to go through basic lighting and mixing desk functionality in the week before the event, preferably Wednesday or Friday.
- Vehicles are not to be brought onto the site. All vehicles are to be parked outside the gates except for loading of equipment.
- Please note: The Rosny Farm operates as a centre for visual and performing arts activities throughout the year. Members of the public may be on site at anytime during normal opening hours.
- Site staff must be informed if alcohol is to be brought onto the site and appropriate licenses must be sighted by Council staff if alcohol is to be sold.
- Public liability insurance certificate of currency must be sited by Council staff
- Plants are not to be disturbed.
- Children must not be allowed to climb on the walls.
- After hours callout fee for technical assistance will be charged at \$105/ hour unless due to faulty equipment.
- By accepting the hire arrangement for the Barn the Client accepts
  responsibility for any equipment damage received during the course of their
  event and will be charged accordingly for repairs/replacement.
- Lost keys will be charged at \$60.

Hirer's will be invoiced by Clarence City Council at completion of the hire for the agreed hire fee plus any additional costs incurred.
