The Poochibald is an opportunity for artists to submit a painting, drawing, print or small sculpture of either their own dog, a dog they know or a famous dog for exhibition in the Schoolhouse Gallery, Rosny Farm.

The exhibition runs from 29th Sept - 22nd October 11am - 5pm Wed - Sun.

Featuring both an adult and two junior sections, there are great prizes.

Entries close Sunday 24th September.

Winners will be announced at the exhibition opening on Thursday 28th September at 5.30pm at the Schoolhouse Gallery.

Prizes are:

Adult 1st prize \$300 voucher, runner up \$150 voucher

Children - Junior (up to 12yrs) 1st prize \$100 voucher, runner up \$50 voucher

Children - Senior (12 - 16 yrs) 1st prize \$100 voucher, runner up \$50 voucher

Please note, photographs will not be accepted. All artworks must feature dogs.

Special Note -

Entries must be delivered free of all charges. No payments whatsoever will be made by the Clarence City Council for freight or other charges incurred in the delivery or return of the entry. Arrangements must be made by the exhibitor.

The conditions of entry and judging for the Poochibald Art Prize 2023.

1. All entries must be the original work of the exhibitor, completed no earlier than two (2) years prior to the first day of the exhibition.

2. Exhibitors must be living and working permanently or temporarily in Tasmania.

3. Each exhibitor may enter a maximum of two (2) works.

4. All 2D adult work must be framed, with screw eyes or mounted, ready to hang. Clarence City Council reserves the right to determine the most appropriate method for displaying works to ensure public safety, and to refuse to display any works deemed inappropriate or unsafe.

Children's artwork may be either mounted on paper ready to be blutaked to wall, or framed.

5. **2D artwork** shall not exceed **100cm in width or height**, or be more than 20cm in depth. Up to 40 inch stretched canvases are acceptable. Artworks exceeding this size will not be accepted.

6. **3D artwork/sculptures** must be no bigger than **30cms** in any direction.

7. Clarence City Council reserves the right to accept or refuse any entry, or delivery of a work at its discretion. No correspondence will be entered into.

8. Works exhibited may or may not be for sale.

9. In the event that an art work is for sale, the exhibitor requests Clarence City Council to sell the entry for the purchase price referred to in the entry form and to deduct from the said purchase price a commission of twenty-five percent.

10. The decision of the judges will be final and no correspondence will be entered into. The conduct and management of matters relating to or arising out of the exhibition shall be at the discretion of Clarence City Council by its authorised servants, agents or contractors.

11. The Council will provide insurance cover against loss of or damage to the Artworks during installation, de-installation and for the duration of the exhibition. The Artist is responsible for insuring the Artwork during transit to and from the Schoolhouse Gallery.

12. Artwork not collected and removed from the Schoolhouse Gallery by the Artist within 30 days of the completion of the exhibition of the Artwork, or as otherwise required by the Gallery Co-ordinator, may at the discretion of the Council, be sold and the financial proceeds of that sale may be retained by the Council for its own purposes.

13. The exhibitor grants Clarence City Council the licence to reproduce the entry by photographs or film for newspapers, magazines, web-based media or television.
